




# **HELP STOP** PINELLAS COUNTY 'S VESSEL EXCLUSION ZONE AT BUNCES PASS

### YOUR INPUT NEEDED

The Pinellas Board of County Commissioners last Tuesday passed an ordinance that creates a Vessel Exclusion Zone at Bunces Pass. TBMIA Chairman Kevin Carlan from Mastry Engine Center and TBMIA's Misty Bottorf are meeting with Commission Chair Pat Gerard tomorrow (Wednesday) at 2pm and are asking for input from members.



This has come as a surprise to everyone. While the commission may have acted within their legal rights, there was little real public notice until it was too late to react. They are citing a safety issue with swimmers and boaters interacting in a confined area, although there does not appear to be any real data to back this up. It seems very poorly thought through and we are hoping that there will be a "Motion to Reconsider" at the Virtual Commission Meeting this Thursday at 9:30. We urge you to contact County
